At this stage of the ITP, a tactical sexual relationship is an ideological condition to weaken the law of value, to weaken concretely the constitution of a property relationship of private property. The constitutional base of a property relationship is the <u>depository of</u> exchange-value, that is based on the process of value, that is, materialize or realize.

The O has fully arrived at the problem of cadre not being able to resolve fundamental ideological differences that are connected to the value of sex, which has a quality of possessiveness. This possessive character of value makes it impossible for members in the PR to negate depositories of exchange-value without the transitive effect of creating new depositories of exchange-value instead of negating them.

The tactical aim of a sexual relationship is to bring the dialectical method in the form:A) systematizing sex as objective function of biology and psychology , and B) in the form of ideological confrontation to sexual problems that are based in exchange-value without creating new depositories of exchange-value, or adding to the magnitude of sexual value.

With regard to the male idealist, the problem in sexual activity is premature ejaculation. (Note: not all male idealists have this problem) With regard to females idealist, the problem in sexual activity is difficulty in reaching orgasm thru sexual intercourse. (note: not all female idealists have this problem) The problem common to both male and female idealists is their ongoing practice in metaphysics of capitalist ideology i.e. exchange-value deriving from their SC.

For clarity sake, metaphysics as referred to here isn't restricted solely to the metaphysician; it refers to the universal nature of metaphysics that is inherent in both idealist and metaphysician. The inherent problem in metaphysics in regard to sexual practice is not connecting conceptually to the internal biological organs and their functions. In a word, the basis of metaphysicial sexual practice lies in not conceptualizing the contradiction in each form of motion in matter. The manifestation of this conceptual difficualty is the overuse of progression motion in personalized implementation in order to realize an orgasm. The continue overuse of this form of motion to realize, as opposed to the process of interconnection to materialize, an orgasm can lead to perversion. With regard to the male and female metaphysicians, their sexual behavior is usually one of manipulative passivity in the use of personal solution. Linked to this, dominantly, the principal aspect in the metaphysicians' sexual activity is maintaining procedural control while in the process of interconnection. A common enjoyment of the metaphysical character is masturbation.

Two ways to view sex: 1) as value, sex is regarded as one's ultimate value-form of selfworth in bring happiness to the relationship or to one's self through the realization or materialization of a baby. With regard to the family, the female is regarded as the value-form internal to the family. On theother hand, the male is regarded as the value-form external to the family; this is due to men's dominant role is society-their supreme rights that are afforded themby private property. So, men as a value-form has relative exchange value with private property of all of its equivalents. Women, on the other hand, as a value-form has relative exchange value in the maintenance and preservation of private property. For the most part this means the female sex produce healthy babies and properly rear them to fit roles as prescribed by the relations of production. 2) As an equivalent form, sex has exchange-value. The use of sex in this regard is to maintain or expand one's commodity exchange-value for the purpose of preserving and obtaining high valuation of confirmation or verification. In this connection, having babies for financial and non-finacial reasons depending on their asset from the view point of tax advantages and financial investment, childern are viewed as an interdependent development of the relative-form of sex; in turn, childern become a particular equivalent of the expanded form of relative-value of sex. Commericalized sex is another equivalent-form of the relative-value form of sex.
